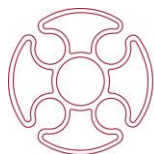
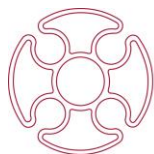

If the wedding service is being recorded then the organist can ask for an increase in the fee stated above.				

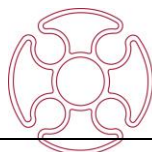

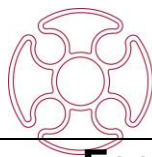

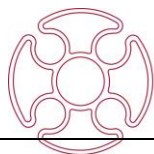
